

9 terrorists involved in suicide attack on security forces arrested

Peshawar, Dec 21 (PTI):

Pakistani police on Thursday arrested nine terrorists, including the mastermind and seven facilitators, involved in one of the worst terror attacks targeting security forces in recent years that killed 23 soldiers in the restive Khyber-Pakhtunkhwa province, authorities said.

Six terrorists linked to Tehrik-e-Jihad Pakistan (TJP), a newly formed militant group that is an affiliate of the banned Tehreek-i-Taliban Pakistan (TTP), rammed an explosive-laden truck into the security post in Dera Ismail Khan in the

South Waziristan tribal district in Khyber-Pakhtunkhwa (KPK) province on December 12, killing 23 soldiers.

The nine terrorists were arrested by the Counter-Terrorism Department (CTD), a wing of the KPK Police.

The mastermind involved in the terror attack belongs to the Islamic Emirate of Afghanistan (Taliban-led Afghan government), they said.

The father of the suicide bomber Sifat Ullah has confirmed his son's connection with the Taliban government to the Daraban area of Dera Ismail Khan while six terrorists involved in the attack hail from Afghanistan, officials said.

According to the documents, five terrorists of the outlawed Tehreek-e-Taliban Pakistan (TTP) Gandapur group were also embroiled in this attack. US-made weapons and ammunition were recovered

from the other suicide bomber; Sifat Ullah Marwat, killed in the attack also established that the attacker belonged to Afghanistan, they said.

According to the Inter-Services Public Relations, the media wing of the army, 23 Pakistan Army soldiers were killed while all six terrorists were "effectively engaged and sent to hell."

On the same day, Pakistan summoned Afghan Charg d'Affaires in Islamabad and delivered a strong demarche to the interim Taliban government in the context of the deadly attack. Pakistan later asked Afghanistan's Taliban government to hand over those involved in the deadly attack on the army post.

Indian national jailed in Singapore for reckless driving

Singapore, Dec 21 (PTI):

A 40-year-old Indian national in Singapore has been sentenced to 10 months in jail for recklessly driving a lorry and causing the death of an elderly woman, a media report said on Thursday.

Sivalingam Suresh on Wednesday pleaded guilty to one charge of driving a lorry without due care and attention and hitting a 79-year-old Chinese-origin woman who was walking across a zebra crossing in Singapore in February this year. The Straits Times newspaper reported.

He carelessly drove the vehicle and hit the woman following which she suffered a head injury and died on the same day, the court was informed. Following the sentencing, Suresh, who has a history of errant driving, will also be disqualified from holding or obtaining all classes

of driving licences for eight years after his release. Deputy Public Prosecutor Benedict Teong said Suresh failed to notice the woman as he approached a zebra crossing alongside Ngee Ann Primary School, colliding with her.

There was no evidence to suggest that the possible mechanical failure of the lorry could have caused or contributed to the accident, the prosecutor said.

DPP Teong asked the court to sentence Suresh to 10 to 11 months in jail and impose a driving ban of eight years. He cited Suresh's history of driving offences, which included inconsiderate driving and failure to conform to a red light.

For causing death by driving a vehicle without due care and attention, Suresh could have been jailed for up to three years and fined up to 10,000 Singapore dollars.

EU countries agree on compromise for overhaul of bloc's fiscal rules

Brussels, Dec 21 (AP):

European Union finance ministers on Wednesday sealed a deal to reform the 27-nation bloc's fiscal rules after France and Germany finally adhered to a compromise.

EU countries had been negotiating for months a reform of the bloc's fiscal rules limiting debt and deficits for member states, known as the Stability and Growth Pact.

The rulebook, which has often proved difficult to enforce and has served as a source of tension, was suspended during the COVID-19 pandemic but should be reactivated next year. "Once this agreement is formalised into a general approach, which should happen very soon, negotiations can begin with the European Parliament so that EU Member States have clarity and predictability on their fiscal policies for the years ahead," said Valdis

Dombrovskis, a European Commission executive vice president.

The deal was announced a day after France and Germany reached an agreement on the compromise put forward by Spain, which currently holds the rotating presidency of the EU. The two economic powerhouses had long remained at odds on how to support investment when budget deficits exceed the limits set by the EU.

"(A) historic agreement," France's Finance Minister Bruno Le Maire wrote on X, formerly Twitter. "After two years of intense negotiations, we have new European budget rules!"

Key targets from the old Stability and Growth Pact will remain. Under current rules, countries must aim to keep their government deficit below 3% of gross domestic product, and their public debt below 60% of GDP.
